 4 **WHEREAS**, this position was not originally included in the Carlson Dettmann
 5 process for creating a wage scale; and,

 7 **WHEREAS**, the Personnel Committee reviewed the job description and
 8 recommended a classification of the position by Carlson Dettmann to ensure
 9 proper compensation; and,

 11 **WHEREAS**, the Finance Committee recommended the position be placed
 12 according to Carlson Dettmann’s analysis which determined the position was a
 13 Grade 9; and,

 15 **WHEREAS**, the Personnel and Finance Committees recommend this position is
 16 placed at Step 6.

 18 **NOW, THEREFORE, BE IT RESOLVED**, that the Rusk County Board of
 19 Supervisors does hereby approve the Finance Accountant II – RCTC position be
 20 placed on Grade 9 at Step 6 of the wage scale at a pay rate of \$23.72/hr after
 21 analysis was completed by Carlson Dettmann.
