Call Meeting to Order.

Highway Chair Jerry Biller called the meeting to order at 8:00 a.m.

Approval of Minutes – October 29, 2018.

A Lieftring/Hraban motion to approve the minutes of October 29, 2018. Motion Carried.

Don Mansky asked about Highway right-of-way.

Approve Resolution to allow ATV/UTV crossing the USH 8 Bridge over the Flambeau River in the City of Ladysmith (Brooklyn Bridge) and forward to County Board.

The Committee reviewed the resolution and discussion followed.

A Lieftring/Stout motion to approve the resolution to allow ATVs/UTVs crossing the USH 8 Bridge over the Flambeau River in the City of Ladysmith (Brooklyn Bridge). Motion Carried.

Approve Ordinance to amend Section 46-37 of the Rusk County Code regarding All-Terrain Vehicle routes and forward to County Board.

Update on "Hunting Restrictions" for all active and inactive mining land.

A Lieftring/Hraban motion to postpone until the December 17, 2018 meeting. Motion Carried.

Review and possible updates on Highway Job Descriptions for Truck Drivers/Operators, and Laborers.

Discussion on proposed changes to the Highway Laborer and Highway Driver/Operator job descriptions; change both job descriptions to have the same requirements except for the level of experience, change the job description titles to Highway Worker Class I to replace Highway Laborer job description title and Highway Worker Class II to replace Highway Driver/Operator job description title. Discussion on level of experience requirements.

A Lieftring/Stout motion to approve changes to job descriptions as follows: change title of Highway Laborer to Highway Worker Class I and Highway Driver/Operator to Highway Worker Class II, change job descriptions for both Highway Worker Class I and Highway Worker Class II to have the same requirements except for the level of experience, set level of experience for the Highway Worker Class II as "a minimum of 3 years' experience as a Highway Worker Class I". Forward changes to the Personnel Committee. Motion Carried.
