9 address numbers in order to maintain the address grid.

11 NOW, THEREFORE, BE IT RESOLVED, the Rusk County Board of Supervisors
12 does hereby amend Chapter 36, Article II, Sec. 36-40 by adding the following
13 language:

15 (d) In the case where a Town has replaced a fire-number sign and within one year, the
16 Land Information/Surveyors office has determined that, an existing number needs to
17 be changed in order to comply with the provisions of this article, the Land
18 Information/Surveyor office shall reimburse the Town for the cost of a new sign (sign
19 only).
