1 **WHEREAS**, Rusk County has been the recipient of Formula Grants for Rural
2 Areas - Operating (5311/85.20) grant and a Specialized Transportation
3 Assistance/Driver's Escort (85.21) grant which fund the Rusk County Transit
4 Commission (RCTC); and,

6 **WHEREAS**, RCTC is a Component Unit of Rusk County; and,

8 **WHEREAS**, RCTC has made a request of the Finance and Personnel
9 Committees to create a part time Finance Accountant II position; and,

11 **WHEREAS**, by making this a county position that is contracted to RCTC, the
12 Finance Director would have oversight of the part time Finance Account II and
13 all costs incurred would be funded by the aforementioned grants; and,

15 **NOW, THEREFORE, BE IT RESOLVED**, that the Rusk County Board of
16 Supervisors do approve the creation of a part time Finance Accountant II position
17 at a pay rate of \$18.49 - \$22.59 per hour; and,

19 **BE IT FURTHER RESOLVED**, that the part time Finance Accountant II
20 position is RCTC grant funding dependent. In the event that grant dollars not be
21 available or not be sufficient to pay the full costs of the position, the position will
22 be eliminated.

24 **BE IT FURTHER RESOLVED**, that the job description for the Accountant II
25 position for RCTC position, which is attached hereto, is adopted.
