1 **WHEREAS**, a part-time position was created for a Finance Accountant II to be
 2 contracted to the Rusk County Transit Commission (RCTC) with Resolution 27-
 3 22 with a wage range of \$18.49-\$22.59/hour
 4
 5 **WHEREAS**, the Rusk County Health & Human Services Finance Accountant I
 6 position has taken on the responsibilities of the RCTC Finance Accountant II in
 7 addition to the HHS Finance Accountant I duties
 8
 9 **WHEREAS**, the wages and benefits related to the RCTC Finance Accountant II
 10 position are to be billed and reimbursed by the Rusk County Transit Commission
 11
 12 **WHEREAS**, this reclassification reduces the wages and benefits expense that
 13 were previously charged to the Rusk County Department of Health and Human
 14 Services budgets for the HHS Finance Accountant I position
 15
 16 **WHEREAS**, the existing wage for the HHS Finance Accountant I is \$20.28/hour
 17 without the responsibility of the RCTC Finance Accountant II duties
 18
 19 **WHEREAS**, the added responsibilities and complexity of the RCTC Finance
 20 Accountant II duties constitutes the need for a higher wage rate and
 21 reclassification of job title
 22
 23 **NOW, THEREFORE, BE IT RESOLVED**, that the HHS Finance Accountant I
 24 position be reclassified to HHS Finance Accountant II effective October 16, 2022
 25 at a rate of \$22.59/hour
