WHEREAS, The Rusk County Drug and Alcohol Court works to reduce substance abuse and criminal behavior in order to improve the lives of offenders, families, and the community by providing court supervision and drug treatment while holding offenders accountable for criminal behavior; and,

WHEREAS, additional assistance is needed with monitoring randomized drug testing of participants and other office-related tasks for the treatment court; and,

WHEREAS, the cost of the positions will be covered by grant funding; and,

WHEREAS, the Part-Time Treatment Court Support Professional job description has been reviewed by the Personnel Committee and a wage recommendation has been made based on current market rates; and,

NOW, THEREFORE, BE IT RESOLVED, the Rusk County Board of Supervisors approves the creation of two Part-Time Treatment Court Support Professional positions to work 10 hours per week with a rate of pay of \$18.00 per hour; resulting in an estimated fiscal impact of \$10,091.02 *2 = \$20,182.04
