5 done by the Department and the Property Committee; and,

8 to assist the current staff with snow shoveling duties and that the cost of the position
9 could be absorbed by the Department's budget

15 Committee and a wage recommendation has been made based on current market rates;

20 hours, with a rate of pay of \$15.00 per hour; resulting in an estimated fiscal impact
