1 WHEREAS, Pursuant to the authority granted under Wis. Stat. §§ 765.15 and 770.17,
2 the total marriage license and termination of domestic partnership fee shall be \$50.50
3 more than the statutorily mandated fee of \$49.50; and

5 WHEREAS, The County Clerk shall charge an additional waiver fee of \$25.00 for each
6 marriage license issued within less than 3 days after application under Wis. Stat. §§
7 765.08; and

9 WHEREAS, The County Clerk is directed to pay into the state treasury that portion of
10 the marriage license and termination of domestic partnership fee-required by law, and to
11 remit the balance thereof and any fees collected under to the county treasury.
12 NOW, THEREFORE, BE IT RESOLVED, that the Rusk County Board of Supervisors
13 does hereby increase the marriage license fee to \$100.00 and increase the waiver fee to
14 \$25.00.

16 BE IT FURTHER RESOLVED, the marriage license waiver fee will take effect on
17 January 1, 2025.
