1 **WHEREAS**, the wage scale indicates that Rusk County has a Child Support  
 2 Specialist I and a Child Support Specialist II; and,  
 3  
 4 **WHEREAS**, the only difference in the two positions is the Child Support  
 5 Specialist II requires two years of experience;  
 6  
 7 **WHEREAS**, past practice has been when a Child Support Specialist I has two  
 8 years of service that they will become a Child Support Specialist II; and,  
 9  
 10 **WHEREAS**, we currently have a Child Support Specialist I on Step 4 making  
 11 \$20.91 per hour, who attained two years of service in September of 2024; and,  
 12  
 13 **WHEREAS**, the HHS Committee and Personnel Committee has met and  
 14 approved the re-classification of the current Child Support Specialist I to be  
 15 placed on Step I of the Child Support Specialist II wage scale which is \$21.06 per  
 16 hour.  
 17  
 18 **NOW, THEREFORE, BE IT RESOLVED**, that the Rusk County Board of  
 19 Supervisors does approve that the current Child Support Specialist I be re-  
 20 classified to a Child Support Specialist II and placed on Step 1 of the wage scale  
 21 at \$21.06, effective January 1, 2025.
