1 **WHEREAS**, pursuant to Wis. Stat. § 59.22(1), the Board must establish the total annual
2 compensation for services to be paid to county elected officials (other than supervisors
3 and circuit judges) prior to the earliest time for filing nomination papers for the county
4 elective offices and;
5 **WHEREAS**, the Board desires to establish the total annual compensation for county
6 elected officials, which is separate and distinct from the fringe benefits offered by the
7 County to elected officials, and which fringe benefits are subject to increase or decrease
8 during the officer's term at the discretion of the Board and in accordance with state and
9 federal law and;
10 **WHEREAS**, as part of the County's fringe benefit program, county elected officials may
11 participate in the Wisconsin Retirement System in accordance with state law and;
12 **WHEREAS**, as part of the County's fringe benefit program, county elected officials may
13 elect to receive health insurance coverage under the same terms and conditions as the
14 health insurance coverage offered to non-represented managerial county employees who
15 are not law enforcement managerial employees or non-represented managerial employees
16 described in Wis. Stat. § 111.70(1)(mm)2 and;
17 **WHEREAS**, it is the responsibility of the Personnel Committee to recommend salaries
18 for elected officials to the Board for final approval; and
19 **WHEREAS**, the Personnel Committee has reviewed the elected officials salaries and
20 recommends the following salaries starting on January 1, 2021 as follows;

30 entitled to participate in the Wisconsin Retirement System in accordance with law and
31 the County shall pay only its share of contributions required by law; and
32 **BE IT FURTHER RESOLVED**, that the aforementioned county elected officials are
33 entitled to participate in the County's health insurance program subject to the terms and
34 conditions of the program, which may be modified from time to time, under the same
35 terms and conditions as the health insurance coverage offered to non-represented
36 managerial county employees who are not law enforcement managerial employees or
37 non-represented managerial employees described in Wis. Stat. § 111.70(1)(mm)2.
38 **BE IT FURTHER RESOLVED THAT**, the elected officials listed above shall be
39 subject to the provision of the fringe benefit programs as set forth in the County
40 Employee Handbook, except as otherwise required by State Law
