

## RUSK COUNTY FAIRGROUNDS USER RATES

### Security Deposit

A Security Deposit of \$500 may be required of all groups using the Fairgrounds and will be cashed. The deposit will be refunded after inspection by Rusk County Maintenance staff at the end of the event if no problems occurred. The deposit shall be forfeited when any of the causes for termination for use are violated.

### User Fees

User fees are due 10 days prior to the event. Insurance verification shall be given to the Extension Office 30 days prior to event.

### Set-up Fees

Half price fees shall be charged for all set-up dates. Fees will only be charged for buildings or areas of the grounds that you will be using on set-up dates.

Non-profit group fees shall only be given to nationally recognized groups and other groups that can prove to the Justice, Youth & Extension Committee that they are a service organization that has given substantially back to the community.

The above fees are intended to cover operating and maintenance costs primarily, but also eventual costs of replacing buildings and equipment. **You must leave the grounds and facilities in a satisfactory condition and return all equipment used or you may be assessed a fee and/or denied future use of the fairgrounds.** Note: Users shall pay any damage to the buildings and contents.

\* Use of the entire grounds excludes the Senior/Youth building, Historical area, Little League fields, Jaycee building, Lions building & pavilion, FFA building and any storage buildings.
