

RUSK COUNTY FAIRGROUNDS USER RATES

Security Deposit

A Security Deposit may be required of all groups using the Fairgrounds and will be cashed. The deposit will be refunded after inspection by Rusk County Maintenance staff at the end of the event if no problems occurred. The deposit shall be forfeited when any of the causes for termination for use are violated.

Buildings-\$500

Equipment-\$250 – for equipment use only

User Fees

User fees are due 10 days prior to the event. Insurance verification shall be given to the Extension Office 30 days prior to event. There is no charge for the last day of event if you're out by Noon. Set-up fees are 1/3 of the rate and limited to 2 days.

Prices do not include tax. Tax will be charged unless proof of tax exemption is submitted.

100% youth participation events are exempt from fees.

Large Event Fee – an additional fee may be charged to groups that have high attendance, complex logistics, require extensive services, specialized staffing and publicity.

The above fees are intended to cover operating and maintenance costs primarily, but also eventual costs of replacing buildings and equipment. **You must leave the grounds and facilities in satisfactory condition and return all equipment used or you may be assessed a fee and/or denied future use of the fairgrounds. All garbage must be disposed of properly in the roll-off container/dumpster provided by Rusk County.** Any garbage that is not taken care of properly can result in a forfeiture of the security deposit. Note: Users shall pay for any damage to the buildings and contents.

** Use of the entire grounds excludes the Senior/Youth building, Historical area, Little League fields, Jaycee building, Lions building & pavilion, FFA building, Chuckwagon, Watering Hole and any storage buildings.
