Jail Regulations for Inmate Visitation

The following are rules and regulations established by the Rusk County Jail Captain. Any violation may result in the termination and/or suspension of your visiting privileges.

All visits will be done through the Rusk County Jail kiosk video visitation system.

Visitation Hours [family kiosk in Rusk County Jail lobby]:

- Tuesdays - 7pm to 9 pm
- Thursdays - 7pm to 9pm
- Saturdays - 1 pm to 5 pm and 7 pm to 9 pm
- Sundays - 1pm to 5 pm and 7 pm to 9pm

Visiting Rules and Regulations:

- Visits are for approximately 25-30 minutes.
- Inmates get one visit per week using the family kiosk. A week is Monday through Sunday.
- All visits will be done via kiosk through the video system. **NO CONTACT VISITS ARE ALLOWED.**
- Hour visits may be requested by the inmate one [1] time a month.
- All visits are recorded.
- Inmate must be housed in general population.
- Approved visitors using the family kiosk must schedule their visits 24 hours in advance. You must have your driver's license number in order to schedule a visit.
- Visitors who cannot make their scheduled visitation must call and cancel prior to their scheduled visit. Failure to do so, will result in the visitor's visits being suspended for TWO [2] weeks.

Jail Regulations for Inmate Visitation

- There may only be two visitors per inmate at a time in the jail lobby. If there are more than two you must wait downstairs in the lobby.
- All visitors must present a valid ID at check in.
- Children under 18 must be accompanied by an adult.
- Visitors who appear to be under the influence of alcohol or drugs will be denied.
- Cell phones, cameras or any kind of recording devices are NOT ALLOWED in the visitation area.
- Any visitors who are disruptive or disrespectful will be told to leave.
- Any no contacts issued by the court, probation, etc., will be enforced.
- Visits may be cancelled or suspended at any time due to unacceptable behavior or and kind of emergency to include severe weather.
- The jail staff may deny any visit to any person when, in the jailers opinion, allowing the visit may present a threat to the safety and security of the jail.
- Scheduled visits may be cancelled at any time for disciplinary reasons. It is the visitor's responsibility to have a current contact number on file. Failure to do so will result in an inconvenience to the visitor.
- Remote visits may be scheduled via Jail ATM.com and be done at any time outside of scheduled family kiosk visits.
- There is no limit on how many remote visits each inmate has.
- Remote inmate visitation is \$0.33 a minute.
- NO NUDITY. Any nudity will result in a 30 day suspension.
- After 30 days, if the offense happens again you are blacklisted forever.
- You are only allowed to visit the inmate you are calling. You may not visit any other inmate in the housing unit. Failure to comply will result in loss of visiting privileges.
