CJCC MEETING
July 15, 2021
Meeting held via Zoom

The meeting was called to order by Chair Jeremy Jacobs with the reciting of the Pledge of Allegiance at 7:31 a.m.

A motion to approve prior month minutes was made by George Murray. Second by Judge Stewart. Carried unanimously.

- Jeremy requested approval from the committee for the Drug Court Supportive Letter that was attached to this month's agenda. The committee approved the letter as there were no comments or corrections. Judge Stewart questions when the grant for next year should be submitted. Holly will find out when it needs to be submitted as this is a competitive year. Holly also stated she will be meeting with the Drug Court Program Evaluator in August.
- George Murray gave an update as to the jail study. Sheriff and Rich Summerfiled are re-wording the resolution that will be presented to the board this month. Mark Schmitt stated the Emergency Committee approved it at the last meeting. George stated it's the board's decision which direction they wish to go. Judge Stewart asked to take a look at the monthly jail numbers. George will start giving those numbers to everyone again very soon. George stated there hasn't been anything Covid related in the jail. They are fully open and all services are being provided. They will also be starting the religious program again with Craig. The Jehovah group will not resume at this time because they are still under restrictions.
- Rich Gauger would like to see an active shooter training for the employees of Rusk County. Judge would like him to come to the Security & Facility meeting in September. Karie to add him to the list. Jeremy explained the ALICE training that happened in Rusk Co. a few years ago. Rich Gauger stated there is an online program that he attended awhile back, which might be an option. Judge Stewart feels court security officers should attend the annual training at Fox Valley. Karie to make sure Jeremy is on the list for the Security meetings.
- Rich Gauger gave an update on RRYP. There has been an increase in JV alcohol citations over the past few weeks. Rich Gauger was also trained in Prime for Life and will be attending a refresher training for MRT.
- Judge Stewart would like to see the CJCC members focus on a different committee each month to allow them to show their efforts of what they have done. Jeremy will email Karie a list with the committee assignments for each month. Jeremy and Judge Stewart feel this would be a way to reinvigorate some of the committees. This will start in September with the main focus being on the Youth Justice Committee.
